# Proposition 39

---

**School districts with charter schools operating in their boundaries may be obligated to provide facilities for charter school students under Proposition 39 (Ed Code 47614).**

## Education Code 47614

---

- Education Code 47614 states:
  - Public school facilities should be shared fairly among all public school pupils, including those in charter schools.
  - Each school district shall make available, to each charter school operating in the school district, facilities sufficient for the charter school to accommodate all of the charter school's in-district students in conditions reasonably equivalent to those in which the students would be accommodated if they were attending other public schools in the district.
  - Facilities offered must be contiguous, furnished and equipped.
  - School district shall make efforts to provide the charter school with facilities near to where the charter school wishes to locate, and shall not move the charter school unnecessarily.

# Proposition 39 Time Frame

---

November 1, 2013	Charter Schools must submit Proposition 39 applications to AUSD
December 1, 2013	AUSD responds indicating questions, objections or requesting additional information
January 2, 2014	Charter schools respond to AUSD objections
February 1, 2014	AUSD to provide to charter schools a preliminary proposal
March 1, 2014	Charter schools respond to preliminary proposal made by AUSD.
April 1, 2014	AUSD submits final offer to Charter Schools.
May 1, 2014	Charter schools must notify AUSD if it intends to occupy the offered space.

# The Academy of Alameda: Requested Scenario for 2014- 15 school year

---

Program	6 <sup>th</sup> - 8 <sup>th</sup> grade
AOA's Requested Facility	Chipman Middle School Site
AOA's projected in-district classroom ADA based on AUSD analysis	365.76
Number of classrooms needed	22 classrooms
Conclusion	AUSD is able to honor AOA's facility request and continue to place them at the Chipman campus.

# Wood Middle School Restructuring for 2014-15 School Year

---

- Wood is in the process of writing their year 4 Program Improvement restructuring plan.
- The plan is to be implemented during the 2014-15 school year.
- Wood plans to utilize an additional 9 classrooms to offer new courses and accommodate possible increased enrollment and new innovative programs.



# BASE Charter School at Woodstock

---

- Lease expires June 30, 2014.
- Base will vacate 6 classrooms and 2 portables located at Woodstock Elementary.
- Base preschool program remains at Woodstock Elementary until the lease expires on June 30, 2015. Preschool occupies 2 classrooms.

# Nea:

## Requested Scenario for 2014-15 school year

---

Program	K-12
Nea's Requested Facility	Entire Program located at Longfellow Campus
Nea's projected in-district classroom ADA based on AUSD analysis	371.52
Number of Classrooms needed	17
Conclusion	Nea's facility request is not viable as there are not enough classrooms available on the Longfellow campus to accommodate the entire school.

# Nea: Possible School Facility for 2014-15 School Year

---

## Option 1: Remain at current facility locations

- K-5 at Chipman Middle School site: 9 classrooms
- 6-12 at Longfellow site: 8 classrooms

Total: 17 classrooms

# ACLC: 2013-14 school year

---

Program	6-12
Facility	Wood Middle School
In-District Classroom ADA	275.19
Number of Classrooms	11

# ACLC:

## Requested Scenario for 2014-15 school year

Program	6-12
ACLC's requested facility	Remain at Wood Middle School with 1 or 2 additional classrooms.
ACLC's projected in-district classroom ADA based on AUSD analysis	295.9
Number of classrooms needed	12 (based on projected in-district ADA)
Conclusion	ACLC's facility request may not be viable due to Wood's facility needs as a result of their restructuring plan.

# ACLC: Alternatives to Wood School Location for 2014-15 School Year

---

- Option 1: Relocate to Woodstock and relocate 4 Adult Education to Chipman or disperse to vacant classrooms in other schools.
- Option 2: Relocate to Woodstock, 2 classrooms at EHS, provide access to 1 science lab at EHS and 2 classrooms at Wood.



# ACLC: Alternatives to Wood School Location for 2014-15 School Year - Continued

---

Option 3: Possible combination of Nea/ACLC Facilities at Woodstock for the 2014-2015 school year

- Nea needs 17 classrooms and ACLC needs 12 classrooms totaling 29 classrooms.
- Place Nea and ACLC in 29 classrooms at Woodstock.
- Implications:
  - Relocate Island High School to Longfellow campus.
  - Relocate Adult Education and Independent Study to available classrooms on the Chipman campus or disburse to vacant classrooms in other schools.
