Item Title: Facilities Update on Historic Alameda High School (Part II)

Item Type: Information

BACKGROUND: Established in the 1920's, the buildings of Historic Alameda High School are currently home to several AHS classrooms and the vacant City library in the west wing, Kofman Auditorium in the center building, and the AUSD District Office in the east wing, as well as the Alameda Adult School in the adjacent building, closest to Oak Street.

In accordance with Field Act requirements, and to ensure student safety, AUSD completed a seismic retrofit of the center building of HAHS (areas commonly used by students) in 1998. Patton Gym also meets these requirements.

Over the last year, AUSD has continued working closely with structural engineers to investigate the seismic safety of the rest of HAHS and concluded that neither the Alameda Adult School nor District Office meet the Field Act requirements. Studies have shown that in the event of a large earthquake, these buildings have the potential of collapsing due to major structural deficiencies.

Staff is currently working on the analysis of additional safety measures to the main section, entrances and exits, the relocation of the Alameda Adult School and the eventual relocation of district office. This is an update to a prior report on February 14, 2012.

Background Information

How did we get here?

- District—Wide Facilities
- California Watch In-Depth Study
- Larry Patton Gym Field Act Certification
- Adult School Windows Project Completion

Areas of Concern

"Main Section" Kofman Auditorium, Student Classrooms, Larry Patton Gym:

- "Main Section" is Field Act Certified by the Department of State Architecture "DSA."
- Second and Third Floor Classrooms and Kofman Auditorium Classrooms were retrofitted with Bond Funds.
- Entrances/Exits and Elevated Walkways are being evaluated to ensure safe passage during a significant seismic event.

Action: Contract for Shoring Study

Areas of Concern

Alameda Adult School:

- Adult School Building "East Wing" has not been retrofitted.
- "DSA" has indicated that Adult School Building is within a K-12 campus and "students" should fall within guidelines of Field-Act and Educational Code.

Action: Classes for Adult School will need to be relocated.

Areas of Concern

District Offices:

- Offices are not retrofitted (Left and right side of Kofman Auditorium)
- Architectural and Engineering study:
 - would likely perform poorly during a large earthquake
 - ➤ lack of proper anchorage from heavy concrete walls to light wood diaphragms has led to collapse of buildings during large seismic event

Action: District Office is recommended for relocation.

Setting Expectations

- Shoring up of Main Section-Entrances/Exits likely to be unattractive
- Perimeter fencing around facility
- Majority of facility will be empty
- Possible loss of some parking
