- LCAP to be adopted by BOE no later than July 1, 2014
- Adopted LCAP to be filed with county superintendent no later than 5 days after adoption
- State Board of Education to adopt evaluation rubric on or before Oct 2015 – county to review LCAP

Beyond 2013-14

 LCAP to be annually reviewed and revised using same procedures of stakeholder engagement

 LCAP report and any revisions to be adopted on or before July 1 and filed with county superintendent no later than 5 days after adoption
