Tier III Background Information

- February 2009 Budget Act
- Tier III Flexibility
- Gave authorization to districts to use funds received for any "Tier III" program to be utilized for "any educational purpose" from 2008-09 through 2012-13
- Has been extended until 2014-2015

Tier III Background

- Categorical Flexibility Tier III Authorization to districts to use funds received for any of these programs for "any educational purpose"
- All program requirements and compliance issues are waived for Tier III programs
- This flexibility allows us to use categorical funds based on the district's goal for student achievement and to direct these limited resources to priorities that we identify as having the greatest impact on student learning.
